

# REFERENCES

should be quoted in the text according to Harvard rules for in-text citation. In-text citations are used when directly quoting or paraphrasing a source. They are located in the body of the work and contain a fragment of the full citation with name of author / authors and year. For example „text of quotation“ (Matlovičová 2015) or (Matlovič and Korec 2011), or (Haggett et al. 2012) or Fitzgerald (2020a, 2020b). References should be in Roman script. Reference list has to be located at the end of the paper and alphabetically display full citations for sources used in the assignment. Each citation in a reference list includes various pieces of information including the: name of the author(s), year published, title, city published, publisher, pages used. Citation of a reference as 'in press' implies that the item has been accepted for publication. Web references require the full URL and the date when the reference was last accessed. Any further information, if known (DOI, author names, dates, reference to a source publication, etc.), should also be given. Web references can be listed separately (e.g., after the reference list) under a different heading if desired, or can be included in the reference list. Examples of most frequent styles:
